**RIDGEWAY ARIZONA OIL CORPORATION'S  
PRE-HEARING STATEMENT**

Ridgeway Arizona Oil Corporation ("Ridgeway") submits its Pre-Hearing Statement pursuant to the rules of the Oil Conservation Division.

**APPEARANCES**

Ridgeway is the applicant in this case. Its business address is 1250 Wood Branch Park Drive, Suite 400, Houston, TX 77079. Ridgeway is represented by the undersigned counsel.

**STATEMENT OF THE CASE**

Ridgeway's application seeks an order pooling all uncommitted mineral interests in the San Andres formation in a 240-acre standard horizontal spacing unit comprised of the NE/4 NW/4 of Section 16, the E/2 W/2 of Section 9, and the SE/4 SW/4 of Section 4, Township 6 South, Range 34 East in Roosevelt County.

The proposed horizontal spacing unit will be dedicated to the Morrison San Andres Unit #942H well, which will be horizontally drilled from a surface location in Unit C in Section 16 to a bottom hole location in Lot 3 in Section 4. The completed interval for the well will be orthodox.
