Gentlemen:

The initial Bone Spring Formation Participating Area "A" is hereby approved effective as of September 17, 2017, pursuant to Section 11 of the Big Eddy Unit Agreement, Eddy County, New Mexico. This participating area has been designated NMNM068294T.

The application establishes an initial Bone Spring Formation Participating Area "A" of 400.000 acres and is based upon the completion of unit well No. DI 5 24H, located in the SW $\frac{1}{4}$ NE $\frac{1}{4}$  (SHL) of Section 27, unit tract No. 78, federal lease NMLC065431, and in the SE $\frac{1}{4}$ NE $\frac{1}{4}$  (BHL) of Section 25, T.20S., R.31E., unit tract No. 88A, federal lease NMLC065914, with an initial potential of 826 BOPD and 878 MCFPD, from the Bone Spring Formation.

Copies of the approved request are being distributed to the appropriate agencies and one copy of Exhibits "A" and "B" are returned herewith. Please advise all interested parties of the approval of the initial Bone Spring Formation Participating Area "A" effective as of September 17, 2017.





