ImPetro Oil & Gas, LLC ("ImPetro" or "Applicant") seeks an order pooling all uncommitted interests in the Wolfcamp formation, Jal; Wolfcamp, West Pool, in the 640 acre, more or less, horizontal spacing unit comprised of the E/2 of Sections 18 and 19, Township 25 South, Range 36 East, NMPM, Lea County, New Mexico. Applicant seeks to dedicate the above-referenced horizontal spacing unit to the following proposed wells: The **Black Marlin Federal Com #1H**, the **Black Marlin Federal Com #2H**, the **Black Marlin Federal Com #3H**, and the **Black Marlin Federal Com #4H** wells to be drilled from surface hole locations in the NE/4 NE/4 (Unit B) of Section 18, T25S, R36E to bottom hole locations in the SE/4 SE/4 (Unit P) of Section 19, T25S, R36E. Also to be considered are Applicant's designation as the operator of the spacing unit and the wells, the cost of drilling and completing the wells and allocation of the costs thereof, as well as the actual operating charges and costs of supervision, and imposing a 200% charge for the risk assumed by Applicant in drilling and completing the wells.
