NOW, on this 1st day of May, 2006, the Division Director, having considered the record and the recommendations of the Examiner,

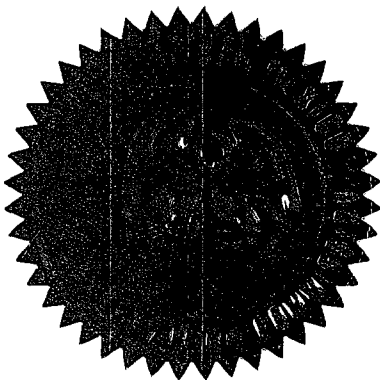
FINDS THAT:


