Item 4. Final action may be taken in:

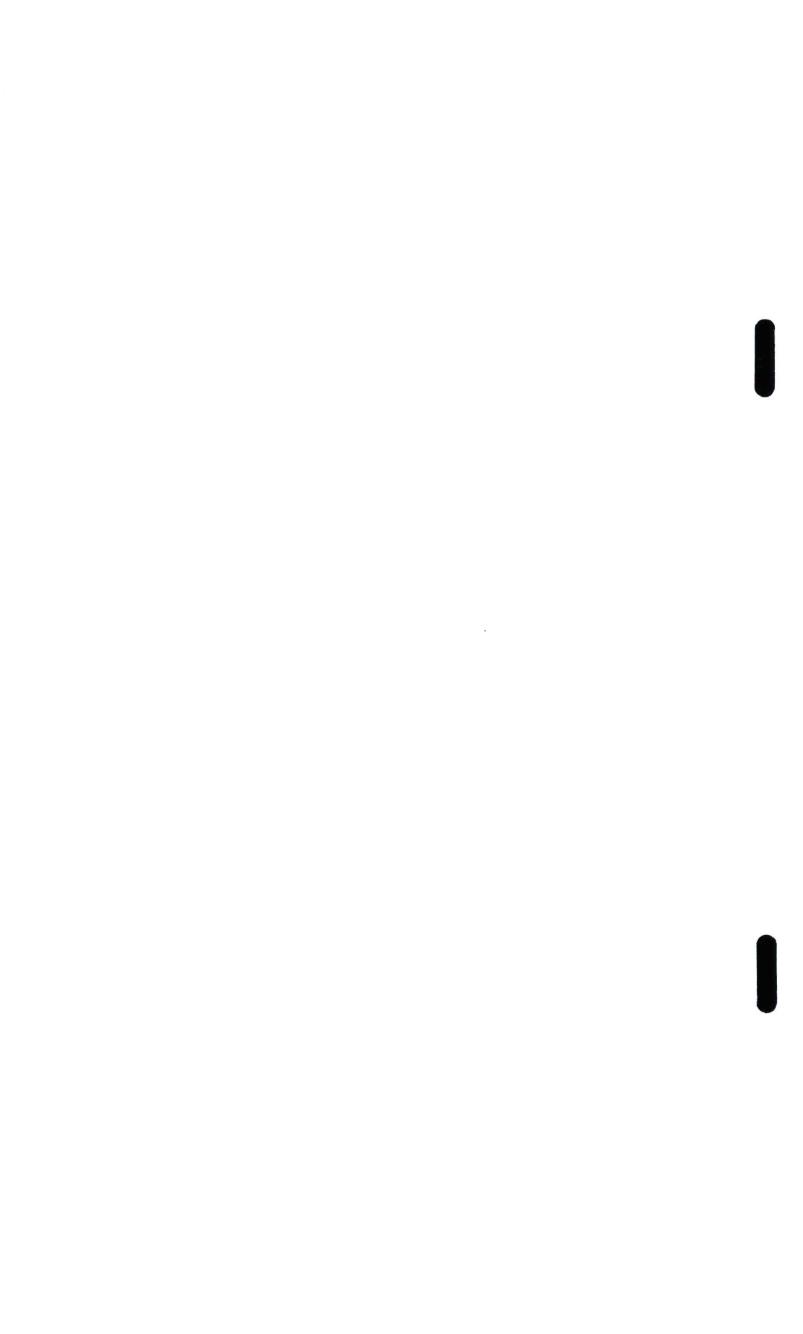
