In the matter of the application of the Oil Conservation Division of the Energy, Minerals and Natural Resources Department upon its own motion for an order for the abolishment and the creation, discovery allowable assignment and extension of certain existing pools in Eddy County, New Mexico, and giving notice to all persons and parties interested in the subject matter thereof, to show cause why such creation, discovery allowable assignment, and extensions and or deletions should not be made.

(A) There is a need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Wolfcamp formation, bearing the designation of Rio Penasco; Wolfcamp Gas Pool. (**Pool Code: 97512**) The Rio Penasco; Wolfcamp Gas Pool was discovered by Mack Energy Corporation, Brazos State # 1 (**API # 30-015-34165**) located in Unit D of Section 18, township 18 South, Range 24 East NMPM, which was completed in the Wolfcamp formation on December 12, 2005. The top of the perforations is at 5479'.
