MR. CARR: May it please the Examiner, my name is William F. Carr with the Santa Fe office of Holland and Hart, L.L.P. I'd like to enter my appearance in this case on behalf of Range Operating New Mexico, Inc.

As you have stated, the case was heard on May the 11th and it was continued to today's date to correct errors in the legal ad. There was potential opposition in that case, but immediately before the hearing an agreement was reached as to certain language that the parties request be included in the order.

Mr. Kellahin represented Range at that time.

Since the hearing, he has provided to the Division evidence that the notice of the Application has been correctly provided.

In discussions with Mr. Catanach who heard the 1 case, today we have agreed that on behalf of Range I would 2 3 present two exhibits, things that Mr. Catanach had 4 requested. 5 Exhibit A is the text of the proposed stipulation 6 between the parties, and Exhibit B is a plugging schematic 7 for the Brantley Com Well Number 1. This schematic was inadvertently left out of the C-108 that was filed with the 8 Application. 9 And so with your permission, I would move the 10 admission of Range Exhibits A and B and request that the 11 case be taken under advisement. 12 EXAMINER JONES: Okay, we'll admit Range Exhibits 13 A and B into evidence, and -- Do you have any questions? 14 MS. MacQUESTEN: 15 (Shakes head) (Off the record) 16 17 EXAMINER JONES: Okay, we have no questions, so we'll take Case 13,705 under advisement. Thank you. 18 19 MR. CARR: Thank you, Mr. Examiner.
