



Ladies and Gentlemen:

You are hereby notified that the New Mexico Oil Conservation Division ("Division") has filed the above-captioned application seeking an order requiring Platinum Exploration Inc. ("Platinum") to properly plug and abandon the Huber State #1 well, and assessing a civil penalty. A copy of the application is enclosed.

A hearing on this application will take place before a Division hearing examiner on Thursday, June 22, 2006, at 8:15 a.m., in Porter Hall, First Floor, 1220 South St. Francis Drive in Santa Fe, New Mexico. At that hearing you will have an opportunity to show cause why an order should not be entered as requested in the application. If you intend to present evidence at the hearing you should file a pre-hearing statement as required by 19.15.14.1211.B NMAC at least four business days in advance of the hearing, but in no event later than the Thursday preceding the hearing date.

Platinum posted a \$50,000 letter of credit through the West Texas State Bank in Odessa Texas to secure its obligation to plug and abandon its wells located in New Mexico. The Division will draw on that financial assurance if an order is entered as requested in the attached application and the Huber State #1 is not plugged by the date set by the order.
