

Ladies and Gentlemen:

By letter dated February 11, 2004, ConocoPhillips as Unit Operator filed the 2004 Plan of Development (POD). The POD indicated that twenty-four (24) wells were planned to be drilled or re-completed. By letter dated July 22, 2004 the POD was amended to include the San Juan 30-5 #93 well. By letter dated July 30, 2004 the POD was amended to include the San Juan 30-5 #206A well. Finally, by letter dated August 31, 2004 the POD was amended to include the San Juan 30-5 #216A and #240A wells. The San Juan 30-5 #21A well was drilled in 2004 as shown below, however, this well was inadvertently omitted from the 2004 POD. The 2004 status is shown below:




