Ladies and Gentlemen:

By letter dated March 31, 2005, ConocoPhillips Company (COPC) as Unit Operator filed the 2005 Plan of Development (POD), which was amended by ConocoPhillips' letter of December 16, 2005. The initial POD indicated forty-nine (49) wells were planned to be drilled in 2005. The first amendment added two (2) additional wells to be drilled.
