Enclosed is one approved copy of Unit Communitization Agreement (CA) NMNM 116873, involving 80.00 acres of Federal land in lease NMNM-03356 and 80.00 acres of Federal land in lease NMNM-03358 in San Juan County, New Mexico. This acreage comprises a 160.00 acre spacing unit for the NEBU No. 231J on Federal land.

The agreement communitizes all rights as to natural gas and associated liquid hydrocarbons producible from the Pictured Cliffs Formation in the SW $\frac{1}{4}$ of Section 14, T. 31 N., R. 7 W., NMPM, and is effective July 23, 2005. This CA shall remain in force and effect for a period of 2 years and for as long as communitized substances are, or can be, produced from the communitized area in paying quantities, and subject lands are not included in a participating area. You are requested to furnish all interested principals with appropriate evidence of this approval.

Any production royalties that are due must be reported and paid within 90 days of the Bureau of Land Management's approval date or the payors will be assessed interest for late payment under the Federal Oil and Gas Royalty Management Act of 1982 (30 CFR 218.54). 


