Attachment 3 is a geologic write-up with a number 1 of maps which I'll let you go through at your leisure, but 2 the unit is based on the Strawn and Atoka geology in the 3 4 area. And then attached to the affidavit as Attachment 5 4 is an AFE for the initial unit well, and the well is an 6 11,500-foot test, with a completed well cost of 7 approximately \$2.2 million. 8 We would simply ask that the Division issue its 9 order approving the unit so that final approval for the 10 unit can be obtained from the Commissioner of Public Lands. 11 And since there are no interest owners, no one 12 was notified in this matter. And besides, it's a voluntary 13 unit. 14 EXAMINER CATANACH: Okay, anything further? 15 16 MR.
