3	EXAMINER CATANACH: All right, at this time I'll
4	call Case 13,835, the Application of Corkran Energy, L.P.,
5	for compulsory pooling, Eddy County, New Mexico.
6	Call for appearances.
7	MR. BRUCE: Mr. Examiner, Jim Bruce of Santa Fe,
8	representing the Applicant. I'm submitting this case by
9	affidavit.
10	EXAMINER CATANACH: Any additional appearances?
11	Okay, you may proceed, Mr. Bruce.
12	MR. BRUCE: Mr. Examiner, submitted as Exhibit 1
13	is an affidavit of the landman under Rule 1207.A.(1), and
14	submitted as Exhibit 2 is the affidavit of notice in this
15	case.
16	Corkran Energy, L.P., seeks to pool the east half
17	of Section 25, 18 South, 26 East, for 320-acre units. The
18	unit is to be dedicated to the Orleans 25 Well Number 1,
19	located at an orthodox location in the northwest quarter,
20	northeast quarter, of Section 25.
21	Attached to Exhibit 1 as attachment A is a
22	listing of working interest owners in the well.
23	Highlighted in green are the six parties who are being
24	force pooled, Pathfinder Exploration, Cannon Exploration,
25	the Elliott Family Limited Partnership, ConocoPhillips, Roy

1 Crow and James Brown.

2	Attached as Exhibit B is the correspondence to
3	those parties. I would note that one of the working the
4	company that was doing the land work is Capstone Oil and
5	Gas Company, and that's why the letter went out on
6	Capstone's letterhead.
7	I would also note that this acreage was
8	previously pooled by Order Number R-12,578, under which
9	WJP Exploration, L.L.C., was the operator. But due to the
10	change of operator and due to an extension of the time
11	planned for drilling the well, this case was filed to get
12	the order in Corkran Energy's name.
13	And if you look at that case file, you'll see
14	that there was correspondence in that case file going back
15	about, oh, well over a year of efforts to obtain the
16	voluntary joinder of the parties in that well, and I'd ask
17	you to take administrative notice of that case file.
18	And then attached as Exhibit C is the AFE for the
19	well, and it's about \$2.3 million for a Morrow test.
20	The affidavit also contains proposed overhead
21	rates which they request be adjusted under the COPAS
22	accounting procedure.
23	Exhibit 2 is the affidavit of notice to the half-
24	dozen parties being pooled. There was one party that
25	All of these addresses are valid. The Elliott Family

Partnership, the item was delivered but it has not been 1 picked up yet, but that is a valid address. 2 MR. BROOKS: Which one was that? 3 MR. BRUCE: The Elliott Family Limited 4 Partnership. 5 MR. BROOKS: Okay, thank you. 6 MR. BRUCE: I have previously mailed items to 7 that address and they've been picked up. It has not been 8 refused, it just has not been picked up yet. 9 And I would move the admission of Exhibits 1 and 10 2 and ask that the matter be taken under advisement. 11 EXAMINER CATANACH: Exhibits 1 and 2 will be 12 admitted. 13 14 I guess I'm a little unclear about the previous 15 order. There was a different company that pooled? MR. BRUCE: A different operator, yes, WJP 16 17 Exploration, L.L.C., and they sold their interest to Corkran Energy. 18 19 EXAMINER CATANACH: Okay, was the well drilled under that order? 20 21 MR. BRUCE: No, it was not. 22 EXAMINER CATANACH: So did the order expire? The order expired. 23 MR. BRUCE: EXAMINER CATANACH: 24 Okay. 25 MR. BROOKS: Okay, it looks like you have green

cards from everybody, then, except Elliott Family Limited 1 Partnership? 2 MR. BRUCE: And they were notified of the 3 4 original hearing in this matter, and the case file will reflect that that address was valid and notice was received 5 in that case, so I do know that's a valid address. 6 7 MR.
