
Enclosed are copies of two applications for compulsory pooling, filed with the New Mexico Oil Conservation Division by Pride Energy Company, regarding:

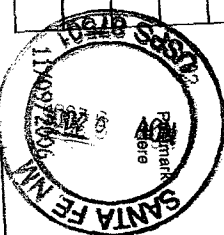


