20 Petroleum Corporation.

21 MR. BRUCE: Mr. Examiner, I was going to present
22 these cases today, and when I was upstairs putting my last
23 exhibits together I found out that there was a defect in
24 the publication notice. There's a couple of unlocatable
25 people in each case. So I'd ask that the cases be

1 continued to January 4th so that the defect can be cured.

2 And I also wanted to state on the record that
3 Pride Energy has come to terms with the Yates group in both
4 of these cases, and they -- at the January 4th hearing they
5 will be dismissed.

6 EXAMINER JONES: Okay, thank you. With that,
7 we'll continue Case 13,830 to January 4th and continue Case
8 13,831 to January the 4th.


