Applicant seeks an order under Division Rule 104 (D)(2) and Rule 6 of the Special Rules and Regulations for the Basin Fruitland Coal Gas Pool (Order No. R-8768, as amended) amending Administrative Order NSL-3572 (NSP) redesignating the nonstandard gas spacing and proration unit currently dedicated to the Florence Gas Com "H" Well No. 1 (API No. 30-045-28624) comprised of the following acreage: Township 30 North, Range 9 West, NMPM; Lots 1, 2, 3, 4, and E/2 W/2 of Section 30 and consisting of 207.84 acres. Applicant proposes that the gas spacing and proration unit be redesignated to conform with the pre-existing Mesaverde formation spacing and proration comprised of the following lands: Township 30 North, Range 9 West, NMPM; Lots 3, 4, E/2 SW/4 of Section 30 and Lots 1, 2, 3, 4, E/2 W/2 of Section 31 and consisting of 308.56 acres, \pm .
