MR. HALL: Mr. Examiner, Scott Hall, Miller Stratvert law firm, Santa Fe, appearing on behalf of the Applicant, Energen Resources Corporation. No witnesses this morning, and appear only for the purpose of introducing an additional exhibit.

EXAMINER CATANACH: Okay, let me call for any additional appearances in this case at this time.

And you may proceed, Mr. Hall.

MR. HALL: Mr. Examiner, this case was heard initially on December 16th, 2006, by Examiner Ezeanyim. In the case the Applicant seeks a reconfiguration of a Basin-Fruitland Coal Gas Pool unit to conform with a pre-existing coal gas communitization agreement and a similarly configured Mesaverde communitization agreement.

At the hearing it was determined that BP, as the 1 owner of interest in acreage that would be excluded from 2 the reconfigured unit, ought to be notified. We didn't do 3 We've since done that, and they have provided us 4 with their waiver of objection to the Energen Application. 5 It's a letter by me to Michael Rogers, their chief landman 6 in Houston. He signed a waiver, and I would offer that 7 into evidence as Exhibit 13. 8 EXAMINER CATANACH: Exhibit 13 will be admitted 9 as evidence in this case. 10 And is there anything further, Mr. Hall? 11 That's all we have, Mr. Examiner. 12 MR.
