There are some -- 50, 51, I 24

believe -- This well must be located in downtown Carlsbad;

there are approximately 38 tracts that comprise the east
half, west half.

In the course of that exercise where we verified notice for you, we identified one interest owner that we had missed. It was a royalty interest owner. Their names are Miller, and they are identified in the new affidavit. We simply renotified them again.

We also got some updated address information for several of the previously unlocatable mineral interest owners for the Brazeal family.

We also took the precaution of renotifying the offset operators, Devon and Chi. Did that notification for this hearing date. We've received no response from anyone.
