STATEMENT OF THE CASE

The Oil Conservation Division (OCD) seeks an order requiring BC & D Operating Inc. (BC & D) to plug and abandon four inactive wells, and authorizing the OCD to plug and abandon the wells if the operator does not do so.

The most recent reports of production or injection are from 2004, with one well last reporting production or injection in 1979. The wells are neither plugged and abandoned nor on approved temporary abandonment status.

The OCD holds a \$50,000 cash blanket bond from BC & D for these wells.


