
APPLICATION

Bold Energy, LP applies for an order approving an application for permit to drill, and to approve two operators on a gas well unit, and in support thereof, states:

1. Applicant is an interest owner in the W $\frac{1}{2}$ of Section 8, Township 19 South, Range 29 East, N.M.P.M.
2. Applicant desires to drill the proposed OXY Checker State Well No. 2, to be located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 8, to a depth sufficient to test the Wolfcamp and Canyon formations.
3. The W $\frac{1}{2}$ of Section 8 is currently dedicated, in the Wolfcamp and Canyon formations, to the OXY Checker State Well No. 1, located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 8, operated by OXY USA WTP Limited Partnership ("OXY").
4. Applicant notified OXY of its desire to drill and operate the OXY Checker State Well No. 2, as required by Division Rule 104.E(2), but OXY objected to the drilling of the well by applicant.
5. Applicant requests that its application for permit to drill be approved so that it may drill and operate the well.
6. The approval of this application will prevent waste and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order approving the relief requested herein.
