Ladies and Gentlemen:

Chaparral CO2, L.L.C., as the Operator of the Cat Head Mesa Unit Agreement No. NMNM 106852X, Socorro County, New Mexico, requests your approval of time to commence drilling of the referenced well until November 1st, 2007.

You had all previously agreed to extend our spud date on this well until August 1, 2007. Now since fledgling raptors have been discovered still in the nest at the location, Chaparral will be unable to meet that extension date. Since the fledglings must mature and we cannot commence building the location until they have left the nest appears to be some time in late July or even into August. Our drilling contractor has asked that we let them pass us by in the line and move to a later time frame which we could meet with the requested November 1 extension. If not we will have to pay stand by time for the rig not only until the raptors leave the nest but also until we could get the location built. This would be very expensive to endure. An extension to November 1 would resolve this issue easily
