APPLICATION

EOG RESOURCES, INC., ("EOG") through its undersigned attorneys, hereby makes application to the Oil Conservation Division pursuant to the provisions of N.M. Stat. Ann. § 70-2-17 (2006), for an order pooling all mineral interests in the Wolfcamp formation, in the N/2 (Lots 1 through 8) of Irregular Section 5, Township 16 South, Range 25 East, N.M.P.M., Eddy County, New Mexico to form a 222-acre project area for a horizontal well and in support of its application states:


1. EOG is a working interest owner in the north-222 acres of said Section 5 and has the right to drill thereon.
2. EOG proposes to dedicate the above-referenced pooled project area to its Tiber A 5 Fee Well No. 1H to be drilled from a surface location 377 feet from the North line and 351 feet from the West line (Lot 4) to a bottomhole location 912 feet from the North line and 660 feet from the East line (Lot 8) of said Section 5.
3. EOG has been unable to locate and seek voluntary agreement for the development of these lands from certain working interest owners in the subject spacing unit. These owners are identified on Exhibit A to this application.
4. Said pooling of interests will avoid the drilling of unnecessary wells, will prevent waste and will protect correlative rights.

5. In order to permit EOG to obtain its just and fair share of the oil and gas underlying the subject lands, all mineral interests should be pooled, and EOG Resources, Inc. should be designated the operator of the well to be drilled.

WHEREFORE, EOG Resources, Inc. requests that this application be set for hearing before an Examiner of the Oil Conservation Division on July 12, 2007 and, after notice and hearing as required by law, the Division enter its order:

- A. pooling all mineral interests in the subject project area,
- B. designating EOG Resources, Inc. operator of this project area and the well to be drilled thereon,
- C. authorizing EOG Resources, Inc. to recover its costs of drilling, equipping and completing the well,
- D. approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures, and
- E. imposing a 200% penalty for the risk assumed by EOG Resources, Inc. in drilling and completing the well against any working interest owner who does not voluntarily participate in the drilling of the well.

Application of EOG Resources, Inc. for compulsory pooling, Eddy County, New Mexico. To: H.M. Brewster or his successors, heirs or devisees. Applicant in the above-styled cause seeks an order pooling all mineral interests in the Wolfcamp formation, in the N/2 of Irregular Section 5, Township 16 South, Range 25 East, N.M.P.M., Eddy County, New Mexico to form a 222-acre project area for a horizontal well. Said unit is to be dedicated to its Tiber A 5 Fee Well No. 1H to be horizontally drilled from a surface location 377 feet from the North line and 351 feet from the West line to a bottomhole location 912 feet from the North line and 660 feet from the East line of said Section 5. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of EOG Resources, Inc. as operator of the well and a 200% charge for risk involved in drilling said well. Said area is located approximately 6 miles northwest of Artesia, New Mexico.
