


APPLICATION

Cog Oil & Gas LP and COG Operating LLC apply for an order approving a non-standard oil spacing and proration unit in the Wolfcamp formation comprised of the E $\frac{1}{2}$ E $\frac{1}{2}$ of Section 16, Township 16 South, Range 30 East, N.M.P.M., Eddy County, New Mexico, and in support thereof, states:

1. COG Oil & Gas LP is an interest owner in the E $\frac{1}{2}$ E $\frac{1}{2}$ of Section 16, and has the right to drill a well thereon.
2. COG Oil & Gas LP proposes to drill its Dasher 16 State Well No. 1, to a depth sufficient to test the Wolfcamp formation, and seeks to dedicate the E $\frac{1}{2}$ E $\frac{1}{2}$ of Section 16 to the well to form a non-standard 160 acre oil spacing and proration unit (project area) for any formations and/or pools developed on 40 acre spacing within that vertical extent. The well is horizontal well, with a surface location 330 feet from the south line and 330 feet from the east line, and a terminus 330 feet from the north line and 330 feet from the east line, of Section 16. The well will be operated by COG Operating LLC.
3. The approval of the non-standard unit underlying the E $\frac{1}{2}$ E $\frac{1}{2}$ of Section 16 will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, applicants requests that, after notice and hearing, the Division enter its order approving a non-standard oil spacing and proration unit (project area) in the Wolfcamp formation comprised of the E $\frac{1}{2}$ E $\frac{1}{2}$ of Section 16.
