Dear Mr. Shackelford:

Devon Energy Production Company, L. P. ("Devon") respectfully requests a farmout of Shackelford Oil Company's ("Farmor") interest in the referenced lands under Federal Oil and Gas Lease NMNM-44594 under the following terms:

1. On or before December 1, 2007, Devon shall commence the drilling of the Initial Well, an approximate 12,800' Morrow test well at a legal location in the SE/4 of Section 22-T19S-R31E, Eddy County, New Mexico.
2. Upon completion of the Initial Well as a well capable of producing oil and/or gas in commercial quantities, Devon shall earn an assignment of all of Farmor's leasehold interest, contractual rights and/or operating rights limited in depth from the surface to 100' below the total depth drilled in the Initial Well and further limited to the drilling and spacing unit for the Initial Well, save and except any currently producing wells in the designated spacing unit.
3. Farmor shall reserve in such assignment an overriding royalty interest on all production attributable to the Initial Well equal to the difference between existing lease burdens and 20%, proportionately reduced. Upon payout of the Initial Well, Farmor shall have the option to convert its reserved overriding royalty interest to a proportionately reduced 20% working interest.
4. Farmor shall receive all well information relating to the Initial Well as customarily obtained during the drilling, testing and completion of the Initial Well.
5. Devon and Farmor shall enter into a formal farmout agreement which shall be superior in all respects to the general terms set forth in this letter agreement.

If the above terms meet with your approval, please indicate by signing and returning a copy of this letter by Monday, July 16, 2007. Should you have any questions or concerns, please feel free to contact me at (405) 228-8589.



Shackelford Oil Co. proposes the following for our 25% working interest in the E/2 of Sec 22:

1. We deliver a net 78% interest retaining an ORRI between existing burdens and 78%.
2. Devon pays us \$100,000.
3. Shackelford retains its 25% interest from the Bone Springs to the surface in all but the 40 acre unit around the Arenosa #2. Devon to assign Shackelford an additional 15% interest from the Bone Springs to the surface.
4. Shackelford to have access to all information on the Arenosa #2 as if they were an interest owner in that well including but not limited to drilling reports, logs ,mudlogs, and cores and access to the rig floor during drilling.
