APPLICATION OF CHEVRON USA, INC. TO EXPAND ITS ENHANCED OIL TERTIARY RECOVERY PROJECT IN THE VACUUM GRAYBURG-SAN ANDRES POOL IN LEA COUNTY, NEW MEXICO

ADMINISTRATIVE ORDER OF THE OIL CONSERVATION DIVISION

Under the provisions of Division Order No. R-4442, as amended, Chevron USA, Inc. has made application to the Division on September 22, 2006 for authorization to expand its Vacuum Grayburg San Andres Unit Enhanced Oil Tertiary Recovery Project in the Vacuum Grayburg-San Andres Pool in Lea County, New Mexico.

THE DIVISION DIRECTOR FINDS THAT:

(1) The application was filed in due form.

(2) Satisfactory information was provided to demonstrate that all offset operators and surface owner have been provided notice of the application.

(3) No objection has been received within the waiting period as prescribed by Rule 701(C).

(4) The proposed injection well is eligible for conversion to injection under the terms of Rule701.

(5) The proposed expansion of the above-referenced enhanced oil tertiary recovery project will not cause waste nor impair correlative rights.

(6) The application should be approved.

IT IS THEREFORE ORDERED THAT:

The applicant, Chevron USA, Inc., is hereby authorized to inject water, CO_2 and produced gas into the Grayburg-San Andres formation, Vacuum Grayburg-San Andres Pool, through selected perforations within the unitized interval from 3,977 feet to 4,909 feet using 2-7/8-inch fiberglass-lined

tubing set in a packer located within 100 feet of the uppermost injection perforations in the followingdescribed well for purposes of tertiary recovery to wit:

Vacuum Grayburg San Andres Unit Well No. 250 (API No. 30-025-38001)

1443' FNL & 1286' FEL (Unit H) Section 1, Township 18 South, Range 34 East;
Injection Interval: Selective Perforations within the Unitized Interval
Maximum Surface Injection Pressure: Water-1,730 psi
CO₂ & produced gas-1,850 psi

IT IS FURTHER ORDERED THAT:

The operator shall take all steps necessary to ensure that the injected fluid enters only the proposed injection interval and is not permitted to escape to other formations or onto the surface.

Prior to commencing injection operations into the well, the casing shall be pressure tested from the surface to the packer setting depth to assure the integrity of said casing.

The casing-tubing annulus shall be loaded with an inert fluid and equipped with a pressure gauge at the surface or left open to the atmosphere to facilitate detection of leakage in the casing, tubing or packer.

The injection well or pressurization system shall be equipped with a pressure limiting device that will limit the wellhead injection pressure to 1,730 psi for water and 1850 psi for CO_2 & produced gas.

The Director of the Division may authorize an increase in injection pressure upon a proper showing by the operator of said well that such higher pressure will not result in migration of the injected fluid from the Vacuum Grayburg-San Andres Pool. Such proper showing shall consist of a valid steprate test run in accordance with and acceptable to this office.

The operator shall notify the supervisor of the Hobbs OCD of the date and time of the installation of injection equipment in the injection well and of the mechanical integrity test so that these operations may be inspected and witnessed.

The operator shall immediately notify the supervisor of the Hobbs OCD of the failure of the tubing, casing or packer in said well and shall take such steps as may be timely and necessary to correct such failure or leakage.

The subject well shall be governed by all provisions of Division Order No. R-4442, as amended, and Rules 702-706 of the Division Rules and Regulations not inconsistent herewith.

The casing-tubing annulus shall be loaded with an inert fluid and equipped with a pressure gauge at the surface or left open to the atmosphere to facilitate detection of leakage in the casing, tubing or packer.

The injection wells or system shall be equipped with a pressure limiting device which will limit the wellhead pressure on the injection well to no more than:

830 psig for water injection 1170 psig for CO₂ injection

The subject wells shall be governed by all provisions of Division Order No. R-4442, as amended, and Rules 702-706 of the Division Rules and Regulations not inconsistent herewith.
