REL Special Pool Rules for TV Penn <GAS>

Dear Gentlemen:

Reviewing the pool rules for the TV Penn <GAS> R-1839 states the wells producing from this pool needs to be no nearer than 990 feet to the outer boundary of the dedicated tract nor nearer than 330 feet to any governmental quarter-quarter section line. Please see the attached list of all the wells at this time producing or intent to drill in the TV Penn <GAS> pool that have been assigned API numbers. To correct this oversight an application for Non-Standard Location for each of these wells needs to be sent to the Oil Conservation Division in Santa Fe with a copy to the Hobbs District office.
