## **APPLICATION**

J. Cleo Thompson & James Cleo Thompson, Jr., L.P. applies for an order approving an unorthodox oil well location, and a non-standard oil spacing and proration unit in the Devonian formation comprised of the S<sup>1</sup>/<sub>2</sub>NW<sup>1</sup>/<sub>4</sub> of Section 13, Township 9 South, Range 37 East, N.M.P.M., Lea County, New Mexico, and in support thereof, states:

1. Applicant is an interest owner in the  $S\frac{1}{2}NW\frac{1}{4}$  of Section 13, and has the right to drill a well thereon.

2. Applicant proposes to drill its JCT Fed. "13" Well No. 1, to a depth sufficient to test the Devonian formation, and seeks to dedicate the S½NW¼ of Section 13 to the well to form a non-standard 80 acre oil spacing and proration unit in the Undesignated Sawyer-Devonian Pool. The Sawyer-Devonian Pool is developed on statewide rules, with 40 acre spacing and wells to be located no closer than 330 feet to a quarter-quarter section line.

3. The JCT Fed. "13" Well No. 1 will be drilled at an unorthodox location 2252.7 feet from the north line and 1550.8 feet from the west line of Section 13. The location is unorthodox due to geologic reasons.

4. Approval of the unorthodox location and non-standard unit will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order approving the relief requested above.
