- 1 EXAMINER EZEANYIM: Good Morning, everybody. We're
- 2 going on the record now. I think before we proceed, I need to
- 3 make a couple of announcements. As you can see, we have a
- 4 different court reporter, Joyce Calvert, by name. So, we lost
- 5 Steve. So we're very happy to have Joyce today.
- 6 And, again, for the attorneys present today and for
- 7 those who are not present, there is something we wanted to be
- 8 given to us on the pre-hearing statements. When you submit
- 9 your pre-hearing statements, if you have witnesses in them,
- 10 please write their name, their title, their phone number, and
- 11 their address below so that we can then ask for more
- 12 information.
- For example, sometimes we review these applications
- 14 and we want to contact the engineer, and there is no way to
- 15 find the name or any information on their portion. So please,
- 16 when you submit your pre-hearing statements next time, give us
- 17 that information so that we can call them directly.
- I know you attorneys are very busy and I know when we
- 19 call we don't get anybody. And what happens is that we put it
- 20 aside until we get some information. But if that information
- 21 is in the pre-hearing statement, we could call the engineer or
- 22 the landman or the geologist and get the information without
- 23 going through the attorney.
- 24 MR. BROOKS: Well, Mr. Ezeanyim, you're an engineer.
- You may be free to do that. As an attorney, I'm not allowed to

- 1 do that because it's prohibited by the code of conduct that
- 2 applies to attorneys. So I will not be contacting witnesses or
- 3 people that are represented by attorneys except through their
- 4 attorneys. You may continue.
- 5 EXAMINER EZEANYIM: Well, yeah. I don't know that.
- 6 I'm not an attorney. But my quest is to get information. We
- 7 do whatever is necessary for us to get at the information,
- 8 otherwise your order will be delayed. My job is to make sure
- 9 that we get the order on time to you.
- On that, too, it's over eight months now we haven't
- filled the second position for an engineer here. So we are
- 12 still looking. But we have been working very hard to make sure
