APPLICATION OF CIMAREX ENERGY CO. FOR A NON-STANDARD OIL SPACING AND PRORATION UNIT AND COMPULSORY POOLING, LEA COUNTY, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing on February 21, 2008 at 8:15 a.m. at Santa Fe, New Mexico, before Examiners David K. Brooks and William V. Jones.

NOW, on this 24th day of March, 2008, the Division Director, having considered the testimony, the record, and the recommendations of the Examiners,

FINDS THAT:

- (1) Due public notice has been given, and the Division has jurisdiction of this case and of the subject matter.
 - (2) In this case, Cimarex Energy Co. ("applicant" or "Cimarex"):
 - (a) seeks an order creating an 80-acre non-standard oil spacing and proration unit (the "Unit") for production from the Wolfcamp formation within the undesignated Denton-Wolfcamp Pool (Pool Code 17290), consisting of the W/2 SW/4 of Section 6, Township 15 South, Range 38 East, NMPM, Lea County, New Mexico; and
 - (b) seeks to pool all uncommitted mineral interests in the non-standard Unit for purposes of drilling the Humboldt 6 State Com Well No. 1 (API No. 30-025-38603).
- (3) The proposed Humboldt 6 State Com Well No. 1 will be drilled vertically in the SW/4 SW/4 (Unit M) of Section 6 at an orthodox oil well location 430 feet from the South line and 430 feet from the West line; kicked off at approximately 9,189 feet

and drilled horizontally within the Wolfcamp formation in a northerly direction to a terminus approximately 9,379 feet deep (11,607 feet measured depth) to an orthodox bottomhole location 2310 feet from the South line and 430 feet from the West line, within the NW/4 SW/4 (Unit L) of Section 6.

- (4) The applicant presented testimony and evidence that:
- (a) The W/2 SW/4 of Section 6 consists of a fee tract covering the NW/4 SW/4 and a state tract covering the SW/4 SW/4.
- (b) Notice was provided to owners of uncommitted interests for purposes of the compulsory pooling of the proposed Unit. Some parties could not be located despite a thorough search effort and some parties have not responded to lease offers or well proposals. Cimarex has made a good faith effort to obtain the voluntary joinder of the interest owners and there has been no opposition to this proposal.
- (c) There are various offsetting operators to the proposed well. Notice was provided to these operators of the proposed non-standard proration unit and in cases where Cimarex is the offsetting operator, notice was provided to the working interest owners as well.
- (d) Due to the proposed horizontal well to be drilled across diversely owned lands within the W/2 SW/4 of Section 6, notice was provided to all interest owners within these lands of the intention of Cimarex to form this non-standard proration unit.
- (e) The horizontal well will be a stepout from existing production and will be downdip from older, vertical wells in the Denton-Wolfcamp Pool. Cimarex will drill the horizontal section in the top portion of the Wolfcamp formation. The risks to the well will be greater because of thinner pay on the fringes of the pool, and potential water production.
- (f) Nearby active Wolfcamp oil wells, located to the west, are vertical wells. In addition, applicant has drilled several horizontal wells to the north. The vertical wells produce at low but steady rates and have production characteristics indicating that horizontal wells may be appropriate to recover additional oil in place and recover it at an accelerated pace. Using horizontal drilling techniques within an 80-acre unit is expected to yield better economics than drilling vertical wells, and will recover oil and gas that would not otherwise be recovered.
- (g) Oil and gas will be produced in the horizontal wellbore from both 40-acre tracts within the 80-acre non-standard Unit.
- (5) No other parties entered an appearance in this case or otherwise opposed the application.

- (6) In order to prevent waste and protect correlative rights, applicant's proposal to form a non-standard oil spacing and proration unit for oil production from the Wolfcamp formation within the undesignated Denton-Wolfcamp Pool (Pool Code 17290) consisting of the W/2 SW/4 of Section 6 should be approved.
- (7) Applicant has the right to drill within this Unit and proposes to drill vertically to the Wolfcamp formation and then drill and complete a horizontal well designed to produce from the Wolfcamp formation within the Unit.
- (8) Two or more separately owned tracts are embraced within the Unit, and/or there are royalty interests and/or undivided interests in oil and gas minerals in one or more tracts included in the Unit that are separately owned.
- (9) There are interest owners in the proposed Unit who have not agreed to pool their interests.
- (10) Applicant should be designated the operator of the subject well and of the Unit.
- (11) Reasonable charges for supervision (combined fixed rates) should be fixed at \$6,000 per month while drilling and \$600 per month while producing, provided that these rates should be adjusted annually pursuant to Section III.1.A.3. of the COPAS form titled "Accounting Procedure-Joint Operations."
- (12) To avoid the drilling of unnecessary wells, protect correlative rights, prevent waste, and afford to the owner of each interest in the Unit the opportunity to recover or receive without unnecessary expense its just and fair share of hydrocarbons, application proposal should be approved to pool all uncommitted interests, whatever they may be, within the Unit.

IT IS THEREFORE ORDERED THAT:

- (1) Pursuant to the application of Cimarex Energy Co. ("Cimarex"), an 80-acre non-standard oil spacing and proration unit (the "Unit") for production from the Wolfcamp formation within the undesignated Denton-Wolfcamp Pool (Pool Code 17290), consisting of the W/2 SW/4 of Section 6, Township 15 South, Range 38 East, NMPM, Lea County, New Mexico is hereby approved. All uncommitted mineral interests are hereby pooled within this non-standard Unit for purposes of drilling horizontally and producing the Humboldt 6 State Com Well No. 1 (API No. 30-025-38603) (the "proposed well") from the Wolfcamp formation.
- (2) Cimarex Energy Co. (OGRID No. 215099) is hereby designated the operator of the proposed well and of the pooled Unit.


- (3) The above-described Unit shall be dedicated to Cimarex's proposed well to be drilled horizontally at orthodox surface and bottomhole locations within the Unit. The operator of the Unit shall commence drilling the proposed well on or before June 30, 2008 and shall thereafter continue drilling the well with due diligence to test the Wolfcamp formation at approximately 9,379 feet vertical depth or 11,607 feet measured depth.
- (4) In the event the operator does not commence drilling the proposed well on or before June 30, 2008, Ordering Paragraph (1) shall be of no effect, unless the operator obtains a time extension from the Division Director for good cause.
- (5) Should the subject well not be drilled and completed within 120 days after commencement thereof, Ordering Paragraph (1) shall be of no further effect, and the Unit created by this Order shall terminate unless the operator appears before the Division Director and obtains an extension of time to complete the well for good cause demonstrated by satisfactory evidence.
- (6) Upon final plugging and abandonment of the Humboldt 6 State Com Well No. 1 (API No. 30-025-38603), and any other well drilled on the Unit pursuant to Division Rule 36, the pooled Unit created by this Order shall terminate, unless this order has been amended to authorize further operations.
- (7) After pooling, uncommitted working interest owners are referred to as pooled working interest owners. ("Pooled working interest owners" are owners of working interests in the Unit, including unleased mineral interests, who are not parties to an operating agreement governing the Unit.)
- (8) After the effective date of this order, the operator shall furnish the Division and each known pooled working interest owner in the Unit an itemized schedule of estimated costs of drilling, completing and equipping the subject well ("well costs").
- (9) Within 30 days from the date the schedule of estimated well costs is furnished, any pooled working interest owner shall have the right to pay its share of estimated well costs to the operator in lieu of paying its share of reasonable well costs out of production as hereinafter provided, and any such owner who pays its share of estimated well costs as provided above shall remain liable for operating costs but shall not be liable for risk charges. Pooled working interest owners who elect not to pay their share of estimated well costs as provided in this paragraph shall thereafter be referred to as "non-consenting working interest owners."
- (10) The operator shall furnish the Division and each known pooled working interest owner (including non-consenting working interest owners) an itemized schedule of actual well costs within 90 days following completion of the proposed well. If no objection to the actual well costs is received by the Division, and the Division has not objected within 45 days following receipt of the schedule, the actual well costs shall be deemed to be the reasonable well costs. If there is an objection to actual well costs within

the 45-day period, the Division will determine reasonable well costs after public notice and hearing.

- (11) Within 60 days following determination of reasonable well costs, any pooled working interest owner who has paid its share of estimated costs in advance as provided above shall pay to the operator its share of the amount that reasonable well costs exceed estimated well costs and shall receive from the operator the amount, if any, that the estimated well costs it has paid exceed its share of reasonable well costs.
- (12) The operator is hereby authorized to withhold the following costs and charges from production:
 - (a) The proportionate share of reasonable well costs attributable to each non-consenting working interest owner who has not paid its share of estimated well costs within 30 days from the date the schedule of estimated well costs is furnished; and
 - (b) as a charge for the risk involved in drilling the well, 200% of the above costs.
- (13) The operator shall distribute the costs and charges withheld from production, proportionately, to the parties who advanced the well costs.
- (14) Reasonable charges for supervision (combined fixed rates) are hereby fixed at \$6,000 per month while drilling and \$600 per month while producing, provided that these rates shall be adjusted annually pursuant to Section III.1.A.3. of the COPAS form titled "Accounting Procedure-Joint Operations." The operator is authorized to withhold from production the proportionate share of both the supervision charges and the actual expenditures required for operating the well, not in excess of what are reasonable, attributable to pooled working interest owners.
- (15) Except as provided in Ordering Paragraphs (12) and (14), all proceeds from production from the well that are not disbursed for any reason shall be placed in escrow in Lea County, New Mexico, to be paid to the true owner thereof upon demand and proof of ownership. The operator shall notify the Division of the name and address of the escrow agent within 30 days from the date of first deposit with the escrow agent.
- (16) Any unleased mineral interest shall be considered a seven-eighths (7/8) working interest and a one-eighth (1/8) royalty interest for the purpose of allocating costs and charges under this order. Any well costs or charges that are to be paid out of production shall be withheld only from the working interests' share of production, and no costs or charges shall be withheld from production attributable to royalty interests.
- (17) Should all the parties to this compulsory pooling order reach voluntary agreement subsequent to entry of this order, this order shall thereafter be of no further effect.

- (18) The operator of the well and the Unit shall notify the Division in writing of the subsequent voluntary agreement of all parties subject to the forced pooling provisions of this order.
- (19) Jurisdiction of this case is retained for the entry of such further orders as the Commission may deem necessary.
