Be advised that the Santa Fe Office is in possession of copies of:

- (1) assignment from Slayton Resources, Inc. to Ricky L. Houston of a working interest in the Featherstone wells;
- (2) assignment from Occidental Permian Limited Partnership to Ricky L. Houston of a working interest in the Donnelly Pan American well no. 1Y; and
- (3) BLM forms 3160-5 executed by Ricky L. Houston requesting that Tom R. Cone be appointed operator of these wells.
