WHEREUPON, the following proceedings were had at 1 2 8:22 a.m.: 3 EXAMINER STOGNER: All right, this hearing will come to order. Please note today's date, February 21st, 4 5 2002. We're here to consider Docket Number 06-02. At this time I will call Case 12,822, which is 6 7 the Application of the New Mexico Oil Conservation Division for an order authorizing the Division to plug one -- that's 8 one -- well in San Juan County, New Mexico. 9 10 Call for appearances. 11 MR. BROOKS: Mr. Examiner, David Brooks, Energy, Minerals and Natural Resources Department, State of New 12 Mexico, appearing for the New Mexico Oil Conservation 13 Division. 14 15 EXAMINER STOGNER: Any other appearances? MR. BROOKS: We have one witness. 16 17 EXAMINER STOGNER: No other appearances, witness is standing. Sir? 18 (Thereupon, the witness was sworn.) 19 MR. BROOKS: Mr. Examiner, one matter I would 20 like to raise on this case. We discovered within the last 21 couple of days that there is a lien on this property, the 22 lienholder has not been notified. 23 Now, the lien is dated 1969, and it purports to 24 25 secure a mortgage -- or a note that's payable and final

maturity in 1971, and the probability is that it's barred by limitations. However, my search of New Mexico law has not revealed that New Mexico has any kind of protective statute, such as Texas has and Colorado also has, which protects people dealing with real estate against the possibility that liens that have not been released of record may have been extended -- the debt may have been extended and renewed by some agreement between the land owner and the mortgagee that's not of record, and I need to do some more investigation of that.

However, since we've already brought Charlie up here, I request to go ahead and present our case in this case, and if we determine in the next week that it needs to be renoticed, then we'll request to reopen and renotice it, and we would hope that we would not have to re-present our case unless somebody else appears, which I regard as most unlikely.

EXAMINER STOGNER: So be it.

MR. BROOKS: Okay, with that said I'll call Charlie Perrin.

Just a few brief introductory remarks about this case.

This is a situation where there is a well that was drilled in 1928 that is presently located under a house in the City of Farmington, and the records of the OCD do

not identify the operator with sufficient precision that he 1 could be found, even if you could find somebody to drill 2 the well in 1928. And therefore we are simply requesting, 3 4 not as usual, an order that the operator plug the well, but simply that the OCD be authorized to proceed to plug the 5 well with the funds from the reclamation fund. 6 7 Very good. May I proceed? EXAMINER STOGNER: Please. 8 9 CHARLIE PERRIN, 10 the witness herein, after having been first duly sworn upon 11 his oath, was examined and testified as follows: DIRECT EXAMINATION 12 BY MR. BROOKS: 13 State your name, please. 14 0. Charlie Perrin. 15 Α. And how are you employed? 16 Q. I'm the senior field rep in Aztec District. 17 Α. And by whom are you employed? 18 Q. The New Mexico Oil Conservation Division. 19 Α. Okay, and what are your duties as senior field 20 Q. 21 rep? We locate and identify plugged and abandoned 22 Α. 23 wells or wells that need to be plugged and abandoned or reclamated. 24 25 Q. Okay, and have you testified before the Hearing

18	you would begin with the second exhibit here, Exhibit		
19	Number 2 in the exhibit stack, and I'll ask you to identify		
20	0 Exhibit Number 2.		
21	A. Number 2 is the original Oil Conservation		
22	Division Aztec record. It's a field card indicating the		
23	original information on the well.		
24	Q. And have you examined the records of the New		
25	Mexico Oil Conservation Division in an effort to ascertain		

if there is any other information within the files and 1 records of the Division, other than this card --2 Α. Yes. 3 -- concerning this particular well? 4 0. Yes, I have. 5 Α. And have you found anything? 6 Q. No, sir. 7 Α. And did you also examine -- I didn't put this in 8 Q. evidence because I didn't think it was particularly 9 relevant, but did you also examine the archives of the 10 daily newspaper? 11 12 Α. Yes, I did. 13 Q. Was that in Farmington or in Aztec? 14 Α. In Farmington. And did you find some reference to this well? 15 Q. Yes, sir, I did. 16 Α. I didn't put it in the exhibit stack, but 17 Q. basically did it indicate anything about who the operator 18 might have been, with any kind of detail? 19 The information it provided listed Cross Black 20 well, and Jack Cross and Bob Blacklock were the people that 21 it indicated. 22 Does the New Mexico Oil Conservation 23 Okay. Q.

Division have -- Well, first of all I'll call your

attention to the date completed shown on this card, and

would you read that date, please? 1 Α. Tt's 9-1-1928. 2 And were the newspaper articles you found about 3 Q. this well approximately contemporary with that date? 4 5 Yes, they were. And have you been able to locate any information 6 ο. 7 that would give you an idea who these people might have 8 been or where they would now be, other than the assumption 9 they're probably in the graveyard? Α. No, sir, I haven't. 10 Okay. Now, there are handwritten notations on 11 Q. Exhibit Number 2 that give a GPS location for this well. 12 Are those your notations? 13 Yes, sir, they are. 14 Α. 15 Q. And did you physically locate this well? Α. Yes, sir, we did. 16 Okay, where is it actually located? 17 Q. In a closet in the middle of the house. Α. 18 And this house is at what address? 19 Q. I don't know 20 that I put that in the record either, but --Α. It's at 1013 East Cedar, in Section 15, Township 21 29 North, Range 13 West. 22 And that's in the northeast quarter of the 23 Q. southwest quarter of that section, correct? 24

I believe that's correct.

Α.

- Q. If you'll look at Exhibit Number 7, I'll ask you to identify that, please, for the record.

 A. 7 is a plat from the Farmington City -- It's a San Juan County, New Mexico, property identification map.
 - Q. And is this a copy of a portion of the assessor's plat from the tax office up there?
 - A. Yes, sir, it is.

- Q. And while this plat doesn't show what quarter section it is, did you and I look at the full plat yesterday and verify that this is, in fact, the northeast quarter of the southwest quarter of Section 15?
 - A. Yes, sir, we did.
- Q. And the point where it says Quad 1, Quad 2, Quad 4 and shows two crossbars, is that the northeast quarter of the southwest quarter of Section 15?
 - A. Yes.
- Q. Okay. And where -- If you move three lots over from the east line there, the lot that's labeled "Triplett, Olen 282-242", is that the lot where the well is located?
 - A. Yes, sir, it is.
- Q. And the mark there with the -- just by that label, just beyond the words "ET AL", is that the location of the well?
 - A. Yes, sir, it is.
 - Q. Okay. Next I will call your attention to OCD

11 Is that a picture of the residence where Exhibit Number 4. 1 this well is located? 2 Yes, it is. Α. 3 And did you take that picture? 4 0. 5 Yes, I did. Α. And does that fairly and accurately depict the 6 Q. 7 present situation of that residence? Yes, sir, it does. 8 Α. 9 Q. Approximately when was it taken? 10 Α. Early January. 11 Of this year? Q. 12 Α. Yes, sir. 2002? 13 Q. Yes, sir. 14 Α. Next call your attention to what's been 15 Q. identified as Exhibit Number 5, OCD Exhibit Number 5, and 16 ask you to identify it. 17 This is a picture in the house of the well, in 18 Α. the immediate area. 19 20 Okay, does that show that somebody apparently has tried to -- Well, tell me what that shows. 21 Α. If you look close, you can see a copper tubing 22 23 coming off the black pipe sticking up out of the ground.

 - A. That's a close-up picture that's been blown up.
- Q. And does that show the copper tubing coming out of the wellhead?
 - A. Yes, sir, it does.
- Q. Okay. Exhibits Numbers 5 and 6, were those photographs taken by you?
- A. Yes, sir, they were.
- Q. And do they fairly and accurately represent the wellhead of this well that we're talking about?
- A. Yes, sir, they do.
 - Q. And were they taken about the same time as --
- 18 | A. Yes, sir.

19 Q. -- Exhibit Number 4? Very good.

Okay, next call your attention to OCD Exhibit

Number 8, and since these are copies of instruments of

record, Mr. Examiner, I believe that we can probably just

read the identification of the exhibits into the record,

and it's probably not necessary to have the witness

identify them, but I will for the sake of connecting this

up.

Exhibits Numbers 8, 9 and 10, were these instruments that you obtained from the Office of the County Clerk of San Juan County, New Mexico?

- A. They are.
- Q. Okay, we'll let the record reflect, then, that

 OCD Exhibit Number 8 is a certified copy of a warranty deed

 from Caroline Triplett to Olen Triplett, dated March the

 22nd of 1942, recorded in Book 207 at page 28 of the Deed

 Records of San Juan County, New Mexico, and I will

 represent to the Examiner that I have plotted the legal

 description on there and that it does appear by the

 assessor's plat, which is Exhibit 7, to include the

 property in question.

Let the record reflect that OCD Exhibit Number 9 is a certified copy of a warranty deed from Olen Triplett and Jennie Lee Triplett to Olen Triplett and/or Jennie Lee Triplett, joint tenants with right of survival and/or their children Jean Bixler and/or Duane Triplett and/or Troy Triplett with rights of survival, dated August 8th, 1996, recorded in Book 1223 at page 915, Deed Records of San Juan County, New Mexico. And again, I will represent to the Examiner that I have plotted this description by the assessor's plat, and it appears to include the land in question.

Let the record also reflect that OCD Exhibit

Number 10 is a copy of a warranty deed from William Olen

Triplett and Jennie Lee Triplett to William Olen Triplett

and/or Jennie Lee Triplett and/or Jean Bixler and/or Duane

Triplett and/or Troy Olen Triplet, joint tenants with

rights of survival, dated August 8th, 1996, recorded Book

1223, page 916, Deed Records of San Juan County, New

Mexico, and I will represent to the Examiner that I have

plotted the description contained in Exhibit Number 10.

Going back and referring to OCD Exhibit Number 7, the deed in Exhibit Number 10 appears to describe the 66-foot lot labeled Triplett, William, et al., on the plat, which is the second lot to the left or to the west of the lot where the well is located, and it's probably not necessary for purposes of this proceeding.

However, I would note the rules of evidence permit an instrument to be authenticated by lay comparison of signatures. I would invite the Examiner to compare the signature of William Olen Triplett on the deed dated -- on Exhibit Number 9 and that on Exhibit Number 10. Note that Exhibit Number 9 is in the name of Olen Triplett and conveys the property conveyed in 1942 to Olen Triplett, and the signature -- it not only includes the name William but appears to be the same signature as that on Exhibit Number 10, and it would appear that it would be a logical

conclusion, we would submit, that William Olen Triplett and Olen Triplett are, in fact, probably one and the same person.

This conclusion, I would submit, is reinforced by the fact that the two deeds both refer to Olen Triplett in one case and William Olen Triplett in another and Jennie Lee Triplett as being husband and wife and to the named persons Jean Bixler and Duane Triplett and Troy Triplett as being their children.

I would next submit Exhibit Number 11, and I won't ask the witness to identify Exhibit Number 11, because this was furnished to me by counsel for the Tripletts and was not procured by the witness. Exhibit Number 11 is a copy of a mortgage from Olen and Jennie Lee Triplett to Beneficial Finance Company of Farmington, New Mexico, dated the 16th of January, 1969, recorded at Book 670, page 241, Records of San Juan County, New Mexico.

Okay, Mr. Perrin, have you examined the well in question?

A. Yes, I have.

- Q. In your professional opinion as a well inspector, does this well need to be plugged?
 - A. Yes, it does.
- Q. And do you know of this well having been produced at any time within recent memory, other than possibly when

it was used to fuel some of these appliances in this house? 1 No, I do not. Α. 2 And the house is presently unoccupied, correct? 0. Correct. 4 Α. Do you know how long it's been unoccupied? 5 Q. No, sir, I do not. б Α. 7 Okay. Do you believe that this well represents a 0. hazard to the environment in its present condition? 8 9 Α. Yes, sir, I do. Now, in order to plug that well, will it be 10 Q. 11 necessary to demolish the residence? Yes, sir, it will. 12 It would be pretty hard to get a pulling unit 13 Q. into the house without breaking it down, right? 14 Α. Absolutely. 15 And do you believe that it's necessary to ο. 16 demolish this residence in order to plug this well, and 17 it's necessary to plug this well in order to protect the 18 environment of the State of New Mexico? 19 I do. Α. 20 Have you tested this well to see if gas comes out 21 Q. of the wellhead when you open it up? 22 We did open the well, we did detect gas with our 23 Α. meter, and it was a real small blow, but it wasn't a 24 25 constant blow.

So in your opinion, is there any reason to 1 0. 2 believe this well would be capable of commercial 3 production? No, sir. 4 Α. 5 On the other hand, the presence of gas, do you Q. regard that as presenting a danger of fire? 6 Α. Yes, sir, I do. Do you also believe that leaving this well open 8 Q. 9 entails the risk of wasted --Absolutely --10 Α. 11 Q. -- natural gas? -- yes, sir. 12 Α. MR. BROOKS: Very good. At this time, Mr. 13 Examiner, I will offer into evidence OCD Exhibits 2 through 14 15 11, inclusive. Oh, I forgot to have him identify Exhibit Number 16 17 3. Q. (By Mr. Brooks) Would you look at Exhibit Number 18 3 and identify it, please? 19 3 is a plugging procedure that I put together to 20 enter the well and properly plug it. 21 22 Q. And in your opinion, if this procedure were followed by a contractor would the well be properly plugged 23 in accordance with the Rules of the New Mexico Oil 24 Conservation Division? 25

1	A. Yes, sir, it will.		
2	MR. BROOKS: Very good, I again tender OCD		
3	Exhibits 2 through 11.		
4	EXAMINER STOGNER: Exhibits 2 through 11 will be		
5	admitted into evidence at this time.		
6	MR. BROOKS: Pass the witness.		
7	EXAMINER STOGNER: Before we do that, let's go		
8	back to Exhibit Number 8. You kept referring to the date		
9	of this as 1942; is that correct?		
10	MR. BROOKS: 1952, I'm sorry.		
11	EXAMINER STOGNER: Okay, so and I believe you		
12	referenced that several times. So that should have been		
13	1952?		
14	MR. BROOKS: That appears to be correct, it		
15	5 appears to be 1952.		
16	EXAMINER STOGNER: Thank you.		
17	EXAMINATION		
18	BY EXAMINER STOGNER:		
19	Q. Let's see, Mr. Perrin, on Exhibit Number 2 you		
20	show a GPS coordinate?		
21	A. Yes, sir.		
22	Q. Now, was that inside the house at the wellbore		
23	itself?		
24	A. We took four corners of the house and then cross-		
25	referenced it.		

Q. Okay.

- A. We couldn't get a reading, couldn't get enough satellites in the house.
 - Q. Okay. Now, the location, you show it to be 2697 from the north, 2847 from the east --
 - A. Yes, sir.
 - Q. -- in Unit G. Is this an oddball-size section or --
 - A. Yes, sir, it is.
 - Q. Ah, it is, okay. Let's see, do you know what the coordinates of that section is, by chance?
 - A. No, sir, I don't.
 - Q. Okay, but it is an irregular section in itself?
- 14 A. Yes, sir.
 - Q. When I look at the description of the property on Exhibit Number 8, it talks about the north -- or I'm sorry, the south 50 feet of the southeast quarter of the northwest quarter. So that well is actually within that south 50 feet, as described there?

MR. BROOKS: Your Honor, I believe not. I believe that if you look at the description, it says all that part of the north half of the northeast quarter of the southwest quarter lying north of the center line of the Animas River, and the south 50 feet of the southeast quarter of the northwest quarter, and I believe that the

well is within the first part of that description. 1 is, it's in the north half of the northeast quarter of the 2 southwest. 3 EXAMINER STOGNER: Okay. Well, Unit G would not 4 be in the southwest quarter. We have a map and everything, 5 I just want to make sure that when we get the description 6 7 here --THE WITNESS: The description on Exhibit 2, Mr. 8 9 Examiner, and the footage on Exhibit 3. (By Examiner Stogner) Exhibit 2 and 3? 10 0. Yes, sir. Α. 11 Let me find 3. Okay, yes. 12 Q. I'm showing two separate problems. 13 Α. Okay. 14 Q. I'm showing 2843 east and 2600 west on Exhibit 15 Α. 16 Uh-huh. 17 Q. 18 Α. -- and I need to re-check that footage, Mike. Okay, if you all will get back on -- Okay, now, 19 Q. in talking about these footages, you've got the GPS 20 coordinates? 21 Correct. 22 Α. 23 0. Were the coordinates on either one of these calculated back to correspond with one of these legal 24 descriptions? 25

Α. Yes, sir, the coordinates, yes. 1 2 EXAMINER STOGNER: Okay. Mr. Brooks, if you'll 3 get back with me on what the approximate -- or which one is proper. 4 MR. BROOKS: I will attempt to reconcile these 5 descriptions, Mr. Examiner. 6 7 (By Examiner Stogner) All right, let's see. Q. In referring to Exhibit Number 6, now when I look at this one 8 -- You've been there and everything. Of course, I'm 9 looking at kind of a two-dimensional view. I see that 10 copper pipe coming down, and it looks like a swage fitting? 11 12 Yes, sir. Α. Now, when I see that, it looks like it has been 13 Q. pulled off and is just hanging out there. 14 15 Α. Yes, sir. Is there another spigot or another outlet coming 16 in off of that wellhead? 17 18 Α. Yes, that's a T -- or actually a four-way. the back side there's another outlet. There's an outlet on 19 20 the front and the one on the top. 21 Q. Okay. How did those outlets appear? Were they 22 corroded? Were they packed? Were they sealed properly? 23 What was your opinion of --Yeah, they were very tight, like they had been 24 Α. 25 sealed.

- Q. Okay. And looking at Exhibit Number 4, it looks like there is a utility meter going into the house, so did they have also a heat source from outside?
- A. Yes, sir, they did. The gas meter in front does go to the house.
 - Q. They weren't selling the gas, were they?
- A. No, sir.

- Q. Okay. Now, did you talk to any of the people that actually lived in the house when it was actually used as the heat source?
- A. Yes, sir, I have.
 - Q. And what was -- Tell me a little bit about that.
 - A. Ms. Bixler indicated to me that when she was a young child her father had driven a piece of pipe into the ground and used to light it and get about a six-inch flame out of it for the children to play in the yard and to feed the chickens. They -- That's the history that I was told.
 - Q. Now, was the house initially built over the well, or is there an add-on to this house?
 - A. There's an add-on to it.
 - Q. Okay. Was the add-on built over it, or the initial part of the house?
- A. It was built over it, the add-on. The property
 was transferred in the early 1970s on a promissory note, I
 guess. The gentleman that took it built the chicken house

1 and the house together, poured the flooring, included them. And then they got the property back in the 1970s in that 2 condition. 3 Okay, so when you talk about the children and the 4 0. 5 piece of pipe stuck into the ground, that was before the house was built over the well? 6 7 Yes, sir. Α. 8 Okay. And you said the second portion of the Q. house was a poured foundation? 9 10 Α. Yes, sir, it is. 1.1 So there's not a crawl space? Q. No, it's all concrete. 12 Α. 13 Q. So there wouldn't be any chance of cumulative --14 Well, there's no place for it to accumulate under a house? 15 Α. We probed around the edges of it and got no detection of gas. 16 17 Q. Oh, okay. You were alluding to some newspaper articles. What paper was that out of? 18 19 It was the Farmington Daily Times, 1928. were two articles. One said that the well east of 20 21 Farmington, close to the fairgrounds, was -- continued to 22 be drilling. Another one said that they were increasing

EXAMINER STOGNER: Okay. Mr. Brooks, is there anything further?

the gas production.

MR. BROOKS: Just, Mr. Examiner, that we are in negotiations with the landowners and -- Well, first of all, let me identify Exhibit Number 1, which is the notice affidavit.

Exhibit Number 1 reflects that notice has been given to the people named in those deeds, namely Olen Triplett, Jennie Lee Triplett, Jean Triplett Bixler and Dale Triplett, who is -- I'm told is the wife of Troy Triplett, who is deceased, and also Duane Triplett.

And if you'll compare the spelling in the affidavit and the spelling in the deed, you'll find that I misspelled Duane Triplett's name, apparently. He actually spells it D-u-a-n-e. The deed is correct, however.

All of those people did receipt for the notice, as you will see on the attachments to Exhibit Number 1.

Furthermore, we have been in communication with Farmington attorney John Dean who represents these people, and while we are asking for authorization to proceed in the public interest on the ground of public necessity, I will not recommend to the Director that we let a contract to plug this well until we have a release of liability from the owners of the property. We are in negotiation for that. They have indicated they will give us such a release, but nothing has been signed as of this date.

We'll tender Exhibit Number 1.

1 EXAMINER STOGNER: Exhibit Number 1 will be 2 admitted into evidence. Okay, Mr. Brooks, should I take this under 3 4 advisement at this time, or do you wish to continue this matter to another date in which we will revisit it, or how 5 do you suggest we proceed at this point? 6 7 MR. BROOKS: I suggest, Mr. Examiner, that you take it under advisement, and if I determine that it's 8 9 necessary to notice this finance company I will request it be reopened and renoticed. 10 EXAMINER STOGNER: Okay. Now, since there's 11 going to be, probably, some different findings than I'm 12 used to, as opposed to just plugging the well and re-13 seeding, if you'll provide me a rough draft order -- I 14 don't -- We're not going to build them a new house, are we? 15 16 MR. BROOKS: No, we are simply going to demolish 17 the existing house, and what they do with the property is up to them. 18 19 EXAMINER STOGNER: Okay, so no reclamation to the 20 degree that --MR.
