1. My name is C.W. Trainer. I reside in Midland, Texas. I am the operator of certain wells in New Mexico that are the subject of the New Mexico Oil Conservation Division's application.

2. This affidavit will provide the New Mexico Oil Conservation Division with the most current status update regarding these wells.

3. Exhibit 1 to the Affidavit is the C-115 report from the NMOCD website which show I have filed Form C-115's for all applicable wells for the months of November and December 2007.

4. Exhibit 2 to the Affidavit is what the NMOCD website shows are the wells that need individual financial assurance.

5. Exhibit 3 to this Affidavit is the list of inactive wells according to the NMOCD website.

6. Exhibit 4 to the Affidavit is a copy of the most recent OCD filings I have made.

7. A representative of C.W. Trainer met with Hobbs District Office staff recently to discuss the Harris Federal Well No. 1 (API No. 30-025-28551) and the Lea DS State Well No. 1 (API No. 30-025-23611). We have reviewed our plans to remediate or reclaim both well sites with them. We have also provided soil samples on the Harris

Federal Well No. 1. As soon as we receive approval from the district office, I have the equipment ready to remediate and/or reclaim those sites.

8. Surface reclamation has occurred at the Gulf State Com Well No. 1 (API No. 30-025-23525), the Hope State Well No. 1 (API No. 30-01059) and the Tower Well No. 2 (API No. 30-025-35093).

9. Also, we have requested the Division witness a pressure test on the Morse Well No. 1 (API -No. 30-025-04995).

10. I am diligently working on addressing the claims outlined in the Division's application and respectfully request that the Division's application be denied.
