

**CASE 13167:** Application of the New Mexico Oil Conservation Division through the Environmental Bureau Chief to Revoke the Permit of A. L. Daugherty to Operate an Oil Treatment Plant and Disposal Facility and to Release Bond; Chaves County, New Mexico. The Applicant seeks an order revoking the permit of A. L. Daugherty to operate an oil treatment plant and disposal facility located at Section 24, Township 8 South, Range 29 East and Section 19, Township 8 South, Range 30 East. The facility was originally permitted under Order No. R-5464. Applicant also seeks an order releasing the bond on the subject facility.
