Dear Mr. Brooks,

By letter dated June 20, 2008, I received a well proposal letter from Mr. Brad Glasscock at BEPCO, (letter enclosed), referencing "Joint Operating Agreement, George Washington Prospect, Clark, et al #1, Section 14, T19N-R2W, Lincoln Parish LA". Along with the well proposal letter was an operating agreement setting forth a contract area of the N/2 of Section 28, T22S-R28E, Eddy County, New Mexico, (copy enclosed). NO AFE was provided in the well proposal package, nor has one been provided to date. The information provided does not set for a well location, the objective depth, the operation to be conducted nor the estimated cost of the operation.

By letter dated July 18, 2008, received July 21, 2008 from Mr. James Bruce, I was notified of a compulsory pooling hearing for the N/2 of Section 17, T22S, R-28E, Eddy County, New Mexico. The above well proposal letter nor the operating agreement match the lands subject to the pooling application. I feel the notice for the compulsory pooling hearing to be held on August 21, 2008 is defective. I request the hearing be postponed until a date and time appropriate after I have been furnished an AFE and proper notice of what the pooling party intends to develop.

Should I elect to participate in whatever operation is being proposed, the operating agreement has many seriously ominous provisions to which I will not subject my interest. By way of example, provisions that require I forfeit my interest, if I elect not to participate in a subsequent operation where a third parties interest is subject to loss, which interest I have not ownership in and cannot control.
