



Enclosed is a copy of an application, filed with the New Mexico Oil Conservation Division by Nadel and Gussman HEYCO, LLC, seeking an order authorizing the drilling of its proposed HEYCO State Well No. 2 at a location 1650 feet from the north line and 1980 feet from the west line of Section 32, Township 20 South, Range 30 East, NMPM, Eddy County, New Mexico. Applicant is also seeking approval of future oil and gas drilling in the W½ of Section 32 without the necessity of going to hearing.

This matter is scheduled for hearing at 8:15 a.m. on Thursday, May 29, 2008, in Porter Hall at the Division's offices at 1220 South St. Francis Drive, Santa Fe, New Mexico 87505. 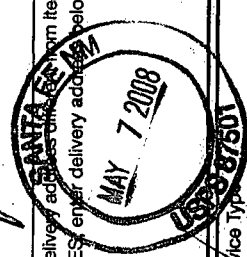
