Pool, and pooling all mineral interests in the Wolfcamp formation underlying the non-standard unit. The unit is to be dedicated to the Caudill South "21" Fee Well No. 3H, a horizontal well to be drilled at a surface location 2000 feet from the south line and 2220 feet from the east line, with a terminus 1700 feet from the north line and 2200 feet from the east line, of Section 21. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The application is scheduled to be heard at 8:15 a.m. on Thursday, July 24, 2008 at the Division's offices at 1220 South St. Francis Drive, Santa Fe, New Mexico 87505.
