STATEMENT OF THE CASE

APPLICANT

Cimarex Energy Co. seeks an order approving a non-standard oil spacing and proration unit (project area) comprised of the E/2NE/4 of Section 23, Township 15 South, Range 37 East, NMPM, to form a non-standard 80-acre oil spacing and proration unit (project area) for any and all formations or pools developed on 40-acre spacing within that vertical extent, including the Denton-Wolfcamp Pool, and pooling all mineral interests in the Wolfcamp formation underlying the non-standard unit. The unit is to be dedicated to the Blanca 23 Fee Well No. 1, a horizontal well to be drilled at a surface location 2160 feet from the north line and 480 feet from the east line of Section 23, with a terminus 330 feet from the north line and 480 feet from the east line of Section 23. Also to be considered will be the cost of drilling and completing the well and the
