STATEMENT OF CASE

APPLICANT

Fasken seeks relief of current over-production of the depth bracket allowable by immediate shut-in of the Cimarex operated wells over-produced in the Apache Ridge-Bone Spring Pool. Further, Applicant requests the shut-in period be determined by the cumulative over-produced oil volume divided by the most recent month daily oil rate or the current depth bracket allowable, whichever is lesser for the following wellbores: Mescalero 30 Federal Well No. 1 (API No. 30-025-29266), located in Section 30, Township 19 South, Range 34 East, NMPM over-production of 10,191 bbls; Pennzoil 36 State Well No. 1 (API No. 30-025-29918) over-production of 5,692 bbls; Pennzoil B 36 State Well No. 2 (API No. 30-025-38300) over-production of 19,440 bbls; Pennzoil B 36 State Well No. 7 (API No. 30-025-38624) over-production of 13,317 bbls, located in Section 36, Township 19 South, Range 33 East, NMPM.
