Application of Julian Ard for a non-standard proration unit or, in the alternative, compulsory pooling, Chaves County, New Mexico. Applicant, in the above-styled cause, seeks approval of a 160-acre non-standard proration unit in the Atoka formation comprising the SE/4 of Section 4, Township 8 South, Range 27 East, or, in the alternative, seeks approval to pool all mineral interests in the Atoka formation underlying the E/2 of Section 4, Township 8 South, Range 27 East, to be dedicated to a well to be drilled at a standard location thereon.
