
Dear Mr. Ramey:

On June 6, 1983 the Division entered Order No. R-7301 in the above-referenced case approving the Application of Morris R. Antweil for Compulsory Pooling of the SW/4 SE/4 of Section 28, Township 19 South, Range 38/East, Lea County, New Mexico. On August 25, 1983 you granted an extension of the time for commencing the well on this acreage until November 1, 1983.

Mr. Antweil advises me that he anticipates commencing the well during November, 1983 and we therefore request an additional extension of time of Order No. R-7301 to December 1, 1983. This will enable Mr. Antweil to go forward with development of the SW/4 SE/4 of Section 28, without the necessity of an additional pooling hearing.
