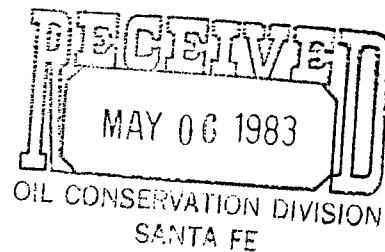

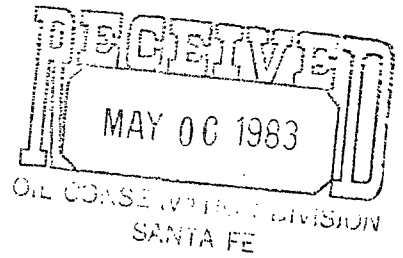

County, New Mexico and in support thereof would show:

1. Applicant has formed its Bisbee Hills Unit,  
composed of State of New Mexico, Federal and fee  
acreage which totals approximately 24,960 acres,  
all as shown on Exhibit "A" attached hereto and  
incorporated by reference.
2. Applicant is designated as operator of the  
proposed unit.
3. The Unit Agreement has been submitted to the  
USGS and to the Commissioner of Public Lands of  
New Mexico for preliminary approval.
4. The said Unit Agreement has been approved by  
sufficient owners of interest to assure its ultimate  
effectiveness.

5. The said Unit is being formed for the Exploration of all formations within the acreage dedicate to it and will give the unit reasonably effective control of operations therein.

6. The granting of this application will result in the prevention of waste and the protection of correlative rights.

WHEREFORE, applicant respectfully requests that this matter be set for hearing before the Division's examiner and that after notice and hearing, the application be granted as requested.
