1 WHEREUPON, the following proceedings were had at
2 8:25 a.m.:

3 EXAMINER CATANACH: And at this time I will call
4 Case 13,137, which is the Application of Richardson
5 Production Company to amend Compulsory Pooling Order Number
6 R-11,812, San Juan County, New Mexico.

7 Call for appearances in this case.

8 MR. KELLAHIN: Mr. Examiner, I'm Tom Kellahin of
9 the Santa Fe law firm of Kellahin and Kellahin. I'm
10 appearing on behalf of the Applicant.

11 EXAMINER CATANACH: Okay, any additional
12 appearances?

13 Okay, Mr. Kellahin?

14 MR. KELLAHIN: Mr. Examiner, this pooling order
15 is still in effect. It's been continued by the Director
16 several times. The only requested change is a change in
17 the well location. The original order had a specific well
18 location, and despite its surface inspection there was a
19 buried irrigation line within the site of the wellpad.
20 When they out to build the location they discovered the
21 irrigation line, and with the cooperation of the surface-
22 use tenant they have proposed to relocate the wellbore to
23 avoid having the pad encroach on the irrigation system.

24 And so the documents you see in the file
25 represent the original location and the proposed amended

1 location. And then if you'll give us a new 90-day clock on
2 the well, we propose to commence that well just as soon as
3 we can obtain an order from you.

4 EXAMINER CATANACH: Mr. Kellahin, the ad
5 represents the new well location?

6 MR. KELLAHIN: Yes, sir, the -- Well, I'm not
7 certain of that, I failed to check that. This was filed
8 administratively with Mr. Brooks, and then subsequently
9 after Mr. Stogner's review he chose to put it on the docket
10 because it was his opinion that we should not amend an R
11 order with an administrative application. So that was the
12 process that this was...

13 EXAMINER CATANACH: That's a very profound --

14 MR. KELLAHIN: Sir?

15 EXAMINER CATANACH: I'm sorry, nothing. I'm just
16 checking to see if that well location is... Okay, it looks
17 to be the correct location, Mr. Kellahin.

18 So, anything further?

19 MR. KELLAHIN: No, sir.

20 EXAMINER CATANACH: Okay. There being nothing
21 further, Case 13,137 will be taken under advisement.


