- CASE 7833: Application of Randolph M. Richardson for a unit agreement, Eddy County, New Mexico. Applicant, in the above-styled cause, seeks approval for the Northeast Artesia Unit Area, comprising 2,560.00 acres, more or less, of State, Federal and Fee lands in Township 16 South, Range 26 East.
- CASE 7834: Application of James C. Whitten for an amendment to Division Order No. R-7154, Lea County, New Mexico. Applicant, in the above-styled cause, seeks the amendment of Division Order No. R-7154 to substitute Discovery Operating, Inc. as the operator under said order.
