Gentlemen and Mesdames:

Each of you own the leasehold and/or mineral interest set out opposite your name on the attached addressee list in the E/2 SW/4 Section 27, T-16-S, R-37-E.

C&K proposes the drilling of an 11,800' Strawn test to be located 1980' FWL and 660' FSL of said Section 27. We attach AFE showing dry hole cost \$913,000 and a completed well for approximately \$1,315,000. We invite your consideration of committing your interest to the drilling of this well by joining in the drilling and paying your share of the costs set out on the attached AFE or by farmout to C&K or by making a lease in favor of C&K as to any unleased mineral interest.

Under a farmout, we propose that we earn 100% of your interest, subject to a 1/16 overriding royalty reserved to yourself, with the option to convert said ORR to 25% working interest after payout of 100% of well costs (all proportionately reduced to your interest, and said override to absorb all burdens in excess of existing royalty). If you prefer to lease to C&K, we would offer 3/16 royalty for a one year lease.

After your review of the enclosed, we ask that you immediately notify us of your intent as we must spud this well prior to October 20 since the leasehold owned by Yates Petroleum will expire on that date. We are scheduled to be heard at a Pooling Hearing before the Oil Conservation Division of the State of New Mexico on September 29, 1982.

Please indicate your desires as to your interest by executing in the space below and returning one copy of this letter. If you elect to join for your interest, please also execute and return one copy of the enclosed AFE.
