Gentlemen and Mesdames:

By letter dated September 10, 1982 we advised you that C&K proposed the drilling of the subject well to a depth of 11,800' to test the Strawn formation and forwarded to you our AFE covering said well.

Certain mineral owners of record objected to the proposed proration unit; therefore we have now redefined the 80 acre proration unit as being the S/2 SW/4 Section 27; T-16-S, R-37-E. We have made Application to Pool said unit and hereto attach copy of the application which is set for hearing on November 10, 1982 before the Oil Conservation Division in Santa Fe, New Mexico.

As a result of our September 10, 1982 letter, Mr. Clifford Cone, Mr. Douglas L. Cone, Petroleum Corporation of Texas, and Heritage Resources have executed our AFE for the drilling of this well. The interests owned by these parties does not change as a result of redefining the proration unit. The interests owned by Texaco, Inc., Roy G. Barton, Jr., E. L. Latham, Jr., and Yates Petroleum do change as a result of redefining the unit. The interest of Ann Morris Marshall increases as a result of title examination.

We herewith submit for your review and approval the following:


