APPLICANT

Cimarex Energy Co. seeks an order approving a non-standard oil spacing and proration unit (project area) comprised of the N/2N/2 of Section 23, Township 15 South, Range 31 East, NMPM, to form a non-standard 160-acre oil spacing and proration unit (project area) for any and all formations or pools developed on 40-acre spacing, and pooling all mineral interests in the lower Abo/Wolfcamp formation underlying the non-standard unit. The unit is to be dedicated to the Monterey 23 State Com. Well No. 1H, a horizontal well to be drilled at a surface location 375 feet from the north line and 575 feet from the east line, with a terminus 375 feet from the north line and 375 feet from the west line, of Section 23. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual

operating costs and charges for supervision, designation of Cimarex Energy Co of Colorado as operator of the well, and a 200% charge for the risk involved in drilling and completing the well.
