MOTION TO DISMISS
H&M DISPOSAL'S UNTIMELY APPLICATION FOR HEARING DE NOVO

Pecos Operating Company ("Pecos") moves to dismiss H&M's Application for Hearing De Novo on the grounds that the Application is untimely. In support this motion, Pecos states:

1. This matter was heard by an Examiners William V. Jones and David K. Brooks on May 15, 2008.
2. On August 4, 2008, the Division Director entered his Order approving Pecos' application.
3. Counsel for Pecos obtained a copy of the Order from the Division's offices on August 6th, thereby indicating the Order was published and made available for pickup by the parties and the attorneys routinely practicing before the Division as early as August 6th. See Attachment A.
4. Section 70-2-13 of the Oil and Gas Act requires any appeal of the Division's order to be filed within thirty days from the time the decision is rendered:

When any matter or proceeding is referred to an examiner and a decision is rendered thereon, any party of record adversely affected shall have the right to have the matter heard de novo before the commission upon application filed with the division *within thirty days from the time any such decision is rendered.*

NMSA 1978, § 70-2-13 (emphasis added).


5. H&M Disposal did not file its Application until September 18, 2008, forty-five days after the decision was rendered by the Division.

WHEREFORE H&M Disposal's Application for Hearing De Novo must be dismissed as untimely.



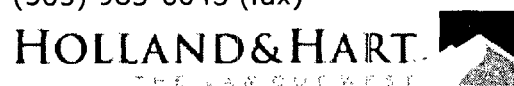
