Dear Mr. Brooks:

You sent me the e-mail attached as **Exhibit A**, requesting information on the W  $\frac{1}{2}$  of Section 15 (incorrectly described as Section 17 in the e-mail). Please be advised that the affidavit of the landman should have described the W  $\frac{1}{2}$  of Section 15 rather than the W  $\frac{1}{2}$  of Section 10. In addition, the only affected party is COG Operating, LLC, which is the operator of record of the offsetting well units in Section 15. **Exhibit B**. Chesapeake was notified because it was a party to the pooling cases on this acreage (Case Nos. 14213, 14214, and 14215). The pooling cases were settled, and COG remains the operator. I am having the affidavit corrected and will provide a signed copy to you.

Dear Jim

It seems I failed to notice a discrepancy regarding notice at the hearing of this case on October 16.

Mr. Tresner's affidavit, in identifying offset operators, includes the W/2 of Section 10, which does not offset the proposed unit, the S/2 N/2 of Section 16. The affidavit omits the W/2 of Section ~~17~~<sup>15</sup>, which does offset the proposed unit. The affidavit identified COG and Chesapeake as owners in the W/2 of Section 10, and those were the parties noticed according to your notice affidavit. The land map attached, however, identified Chesapeake and Harvey E. Yates as owners in W/2 of Section ~~17~~<sup>15</sup>, the correct offset.

Please have Mr. Tressner furnish a correct affidavit. If there is any owner in the W/2 of Section ~~17~~<sup>15</sup> who is an "affected person," who has not received notice, we will have to re-set this case to give the appropriate notice. That may not be necessary, however. Our system shows that COG operates three offsetting wells in Section 15 - its Hercules ## 1, 2 and 3. However, I have not been able to ascertain in what formation those wells are completed if they are. If those wells are completed in the Wolfcamp, then COG is the Division-designated operator, and no one else would need notice.
