Gentlemen:

In accordance with Section 10 of the Poker Lake Unit Agreement dated March 18, 1952, BEPCO, L.P., Operator of the referenced unit, hereby submits an Amended Plan of Development for the Poker Lake Unit for the year 2008. The subject wells will not spud until 2009; however the BLM has requested that they be added to the Plan of Development for the year in which the application for a drilling permit is submitted. This amendment is being filed specifically for the addition of the following proposed wells:

FUTURE DEVELOPMENT

<u>Poker Lake Unit No. 300-H, Eddy County, New Mexico</u> - This well will be drilled at a legal location being 990' FSL & 2,310' FWL, Section 27, T24S-R30E, Eddy County, New Mexico to a proposed depth of 10,650' to test the Delaware Formation.

<u>Poker Lake Unit No. 301H, Eddy County, New Mexico</u> - This well will be drilled at a legal location being 2,310' FNL, 2,310' FWL S ection 27, T24S-R31E, Eddy County, New Mexico to a proposed depth of 9,970' to test the Delaware Formation.

<u>Poker Lake Unit No. 306, Eddy County, New Mexico</u> - This well will be drilled at a legal location being 1,900' FSL & 2000' FWL Section 29, T25S-R30E, Eddy County, New Mexico to a proposed depth of 7,600' to test the Delaware Formation.

<u>Poker Lake Unit No. 307, Eddy County, New Mexico</u> - This well will be drilled at a legal location being 2,400' FNL & 2,200' FWL Section 34, T24S-R30E, Eddy County, New Mexico to a proposed depth of 7,600' to test the Devonian Formation.
