In accordance with Section 10 of the Big Eddy Unit Agreement dated April 10, 1952, BOPCO, L.P., Operator of the referenced unit, hereby submits a Plan of Development for the Big Eddy Unit for the year 2009.

HISTORY OF PAST DEVELOPMENT

We refer to our previous Plans of Development for a detailed description of the operations conducted in this Unit in prior years.

2008 ACTIVITY

Big Eddy Unit Well No. 152, Eddy County, New Mexico – This well was drilled at a legal location being 1,980' FSL & 660' FEL Section 26, T21S-R28E, Eddy County, New Mexico. This well was completed in the Morrow Formation.

Big Eddy Unit No. 162 Well, Eddy County, New Mexico – This well was drilled at a legal location being 1,980' FNL & 2,080' FEL, Section 7, T21S-R29E, Eddy County, New Mexico. This well was completed in the Morrow Formation.

Big Eddy Unit No. 160 Well, Eddy County, New Mexico – This well was drilled at a legal location being 1,830' FWL & 1,140' FNL, Section 10, T22S-R28E, Eddy County, New Mexico. This well is completing in the Atoka Formation.

Big Eddy Unit Well No. 166, Eddy County, New Mexico – This well was drilled at a legal location being 2,380' FSL & 660' FEL, Section 11, T21S-R28E, Eddy County, New Mexico. This well was completed in the Morrow Formation.

Big Eddy Unit No. 168 Well, Eddy County, New Mexico – This well was drilled at a legal location being 660' FSL & 1,980' FEL, Section 16, T21S-R28E, Eddy County, New Mexico. This well was completed in the Morrow Formation.

Big Eddy Unit No. 171 Well, Eddy County, New Mexico – This well was drilled at a legal location being 1,760' FNL & 820' FWL, Section 25, T22S-R28E, Eddy County, New Mexico. This well was completed in the Morrow Formation.

Big Eddy Unit Well No. 202, Eddy County, New Mexico – This well was drilled at a legal location being 1,980' FNL & 660' FWL, Section 24, T21S-R28E, Eddy County, New Mexico. This well was completed in the Morrow Formation.

Big Eddy Unit Well No. 213, Eddy County, New Mexico – This well was drilled at a legal location being 1,650' FSL & 660' FWL, Section 5, T22S-R28E, Eddy County, New Mexico.

Big Eddy Unit Well No. 218, Eddy County, New Mexico – This was drilled at a legal location being 660' FNL & 660' FWL, Section 17, T22S-R28E, Eddy County, New Mexico to a depth of 12,450' to test the Morrow Formation.

Big Eddy Unit Well No. 220, Eddy County, New Mexico – This well was drilled at a legal location being 810' FSL & 1,980' FEL, Section 9, T21S-R29E, Eddy County, New Mexico to a depth of 12,975' to test the Morrow Formation.

FUTURE DEVELOPMENT

Big Eddy Unit Well No. 199, Eddy County, New Mexico – This well will be drilled at a legal location being 1,650' FSL & 1,850' FWL, Section 18, T21S-R28E, Eddy County, New Mexico to a proposed depth of 12,100' to test the Morrow Formation.

Big Eddy Unit Well No. 200, Eddy County, New Mexico – This well will be drilled at a legal location being 1,980' FNL & 990' FWL, Section 21, T21S-R28E, Eddy County, New Mexico to a proposed depth of 12,360' to test the Morrow Formation.

Big Eddy Unit Well No. 208, Eddy County, New Mexico – This well will be drilled at a legal location being 660' FNL & 660' FWL, Section 1, T22S-R28E, Eddy County, New Mexico to a proposed depth of 12,800' to test the Morrow Formation.

Big Eddy Unit Well No. 221, Eddy County, New Mexico – This well will be drilled at a legal location being 660' FNL & 2,030' FWL, Section 27, T21S-R29E, Eddy County, New Mexico to a proposed depth of 13,350' to test the Morrow Formation.

Big Eddy Unit Well No. 222, Eddy County, New Mexico – This well will be drilled at a legal location being 1,980' FSL & 1,650' FEL, Section 29, T21S-R29E, Eddy County, New Mexico to a proposed depth of 12,810' to test the Morrow Formation.

Big Eddy Unit Well No. 225, Eddy County, New Mexico – This well will be drilled at a legal location being 1,980' FSL & 660' FEL, Section 34, T21S-R29E, Eddy County, New Mexico to a proposed depth of 13,400' to test the Morrow Formation.

Big Eddy Unit Well No. 240, Eddy County, New Mexico – This well will be drilled at a legal location being 660' FNL & 990' FWL, Section 33, T21S-R28E, Eddy County, New Mexico to a proposed depth of 12,475' to test the Morrow Formation.

Big Eddy Unit Well No. 243, Eddy County, New Mexico – This well will be drilled at a legal location being 1,750' FSL & 1,650' FWL, Section 4, T22S-R28E, Eddy County, New Mexico to a proposed depth of 12,550' to test the Morrow Formation.

Big Eddy Unit Well No. 245, Eddy County, New Mexico – This well will be drilled at a legal location being 840' FNL & 1,475' FEL, Section 6, T22S-R28E, Eddy County, New Mexico to a proposed depth of 12,300' to test the Morrow Formation.

Big Eddy Unit Well No. 246, Eddy County, New Mexico -- This well will be drilled at a legal location being 1,350' FSL & 940' FEL, Section 3, T22S-R28E, Eddy County, New Mexico to a proposed depth of 12,700' to test the Morrow Formation.

OFFSET OBLIGATIONS
